Their product range covers EMC Components, Inductors, RF Inductors and LTCC Components, Transformers, Components for Circuit Protection, Power Modules, LEDs, Connectors, Switches, Power Elements in Press-fit Technology and Assembly Technique. The company is one of Europe's largest manufacturer of passive components.

## The Purpose of the Position and Key Duties include the following:
